





# Reach Every Child Gavi Pledging Conference 2016-2020 Berlin, January 27, 2015 Chair's Summary

- 1. High level representatives from government and private donors, implementing countries, civil society and Alliance partners assembled in Berlin on 27 January 2015, to pledge support for Gavi, the Vaccine Alliance. The goal was to raise multi-year predictable funding to immunise an additional 300 million children in developing countries by 2020 against some of the world's deadliest diseases and save up to 6 million lives. This ambition represents an unprecedented scale up in immunisation coverage and will generate up to \$100 billion in economic benefits.
- 2. Over US\$ 7.5 billion was pledged by 31 public and private sector donors, which means that Gavi, the Vaccine Alliance is well positioned to achieve these milestones, expand vaccine coverage, strengthen health systems and accelerate the introduction of new vaccines. The pledges announced today will be combined with US\$ 2 billion in resources already committed for the 2016-2020 period to enable Gavi to meet the US\$ 9.5 billion cost of funding vaccine programmes in developing countries over the next five year period.
- 3. The "Reach Every Child" Pledging Conference in Berlin was hosted by the German government under the patronage of Chancellor Angela Merkel and Federal Minister Gerd Müller. Chancellor Merkel was joined by H.E. Dr. Jakaya Mrisho Kikwete, President of the United Republic of Tanzania and H.E. Mr Ibrahim Boubacar Keïta, President of the Republic of Mali, Erna Solberg, Prime Minister of Norway, Donald Kaberuka, President of the African Development Bank, Bill Gates, Co-Chair of the Bill & Melinda Gates Foundation, Ministers from more than 20 implementing and donor countries, civil society groups, CEOs of vaccine manufacturing companies, UN agencies and others (See attached List of Participants).
- 4. Chancellor Merkel noted that 2015 is a decisive year for sustainable development. She was pleased to host the Gavi replenishment as the first event of her G7 Presidency and she outlined the key global health priorities for the G7. The UN Secretary General called on participants to renew investments in Gavi, which are vital to contributing to the gains made through the Every Woman Every Child movement and in ending all preventable maternal, child and adolescent deaths in the sustainable development goals era.
- 5. Bill Gates set out the compelling case for immunisation as a highly cost-effective means to improve health and the critical role that Gavi plays in improving equity in access to life saving vaccines. He highlighted the vital role of innovation in driving an increase in vaccine coverage. Dr. Seth Berkley CEO of Gavi outlined Gavi's resource needs for 2016-2020 and the case for investing in Gavi.
- 6. In the global health leaders' session, Chancellor Merkel, Prime Minister Solberg of Norway together with Secretary of State Greening of the United Kingdom, USAID Administrator Shah and President of the African Development Bank Kaberuka all agreed that immunisation is a sound investment, a game changer for economic growth and acknowledged the links between immunisation and global health







security. Leaders also noted that the Ebola crisis confirmed the importance of strengthening fragile health systems.

- 7. H.E. President Kikwete and H.E. President Keïta reiterated their commitment to immunisation and highlighted the significant impact of immunisation programmes in reducing morbidity and mortality rates in their countries. Through co-financing, Gavi implementing countries are making strong financial contributions towards immunisation. Between 2016 and 2020, Gavi forecasts that developing countries will contribute a combined total of around US\$ 1.2 billion towards Gavi-supported programmes.
- 8. Donor representatives reconfirmed their resolute support for Gavi. The reasons cited included Gavi's continuous drive for innovation, including new approaches to development financing; the transformative impact of strong immunisation systems; and Gavi's unwavering commitment to delivering results, value for money and transparency. Gavi's public private partnership approach was cited as a model for future development initiatives. Dr. Jasmine Whitbread, CEO of Save the Children International reconfirmed civil society's role in advocating for immunisation and in helping to deliver immunisation services in the hardest to reach areas, which will be key to Gavi's success in the next period.
- 9. 22 sovereign donors delivered pledges (See attached Table of Pledges). Four new donors, China, Oman, Qatar and Saudi Arabia, made pledges to Gavi for the first time. China's pledge means that all BRICS countries have made financial contributions to Gavi. Of the support from sovereign donors, US\$ 252 million was committed to the International Finance Facility for Immunisation (IFFIm). In addition, the Gavi Matching Fund, a fund that doubles private sector contributions and impact, will be renewed for the 2016-2020 period with the support of the Bill & Melinda Gates Foundation, the Netherlands and other possible sponsors. Participants recognised that many donors increased their contributions by two or three fold compared to the 2011-15 period.
- 10. Participants welcomed recent price reductions and commitments by vaccine manufacturers to maintain affordable vaccine prices for up to 10 years after graduation from Gavi support. This will not only help Gavi procure more doses of vaccines but also increase the sustainability of vaccine programmes for implementing countries. Countries whose economic status means they are no longer eligible for Gavi support will still have access to many vaccines at the same price Gavi pays for a number of years.
- 11. Participants regarded the success of the Gavi pledging conference as an important early milestone in a critical year for defining the future of sustainable development. They also expressed their deep appreciation for Chancellor Merkel's leadership in hosting the conference and the strong support and warm hospitality of Federal Minister Dr. Müller and the German authorities.
