What does the charity do?

What program does the charity implement, and what role does the charity play (i.e. providing funding, technical assistance, direct implementation, or other)?

AIP Foundation is a U.S. 501(c)(3) nonprofit organization dedicated to preventing road injuries and fatalities. The organization has been delivering effective road safety programs in locations across Asia and Africa for 19 years. We design and implement a broad range of road safety and road crash prevention programs dealing with helmet safety, speeding, worker safety, pedestrian safety, and the like. For the purpose of the GiveWell Grant, AIP Foundation is seeking additional funding for helmet distribution activities through our *Helmets for Kids* program implemented in Vietnam, which provides quality child helmets to students and children in rural, underserved communities for free in addition to other critical program activities. As such, AIP Foundation is the direct implementer of the program with responsibility of program ideation; partnership facilitation; helmet design, procurement, and distribution; school selections; stakeholder engagement; awareness raising; and monitoring and evaluation. What is the evidence that the program works?

Every year, 1.35 million people die and an additional 50 million are injured on the roads. In Vietnam, 24,970 die every year as a result of road crashes and 499,400 are estimated to sustain injuries, which is a significantly higher rate than the global average (WHO 2018).

In a country where motorcycles are the default vehicle and increasing in usage by the millions per year (59.2 million as of 2018), wearing a quality helmet while driving or riding on a motorcycle reduces the risk of death by 42% and head injury by 69% in the event of a crash (Cochrane). While other factors contribute to road crashes, individuals can ensure their own safety through the wearing of quality helmets.

In Vietnam prior to the national helmet law of 2007, helmets were rarely worn by drivers and passengers on motorcycles despite the rapid motorization and congestion of roads and stark increase of road crash-related deaths per year in the country. For children, the issue is even worse – laws mandating helmet wearing for children were not passed until 2010. Helmet wearing among children remains consistently lower than that of adults, and in rural provinces it can be almost non-existent.

To celebrate the tenth anniversary of the national helmet law that AIP Foundation advocated for, we published *Head First: A Case Study of Vietnam's Motorcycle Helmet Campaign* in 2017, which details the decade-long campaign to secure the legislations, and the decade-long implementation effort since. The report compiles years of collected data, case studies, research, and monitoring and evaluation results to highlight the successes of ten years of mandatory helmet wearing and the road ahead. Notably, we conducted costs-savings analysis of the ten years of the helmet law and found that radical increases in helmet use saved \$3.5 billion USD, prevented 502,774 head injuries, and saved 15,302 lives.

Through *Helmets for Kids* programs throughout the years, AIP Foundation has been able to not only provide life-saving tools to children, but also equip them with the knowledge and awareness of the importance of helmets. Helmet wearing rates among children at our program schools have risen significantly post-intervention and have remained that way after second and third post-intervention monitoring observations. In the 2017-2018 school year alone, helmet wearing rates among children at program schools in Vietnam rose from an average of 14,2% to 86.7%.

AIP Foundation has facilitated *Helmets for Kids* with various partners at varying levels of financial support throughout the years. Dollar for dollar, our helmet interventions stretch far and wide, reaching thousands upon thousands of children and adults across the country. For instance, our *Helmets for Kids* program in collaboration with Johnson & Johnson has reached 61 schools across 7 provinces (Dong Nai, Ha Tinh, Quang Binh, Quang Nam, Gia Lai, Yen Bai, Thai Nguyen) in Vietnam, and provided 56,689 helmets since 2012.

Of the thousands of students served by *Helmets for Kids*, meet one student who participated in the program during the 2016-2017 school year. Ro Cham Hoang Anh lives in Gia Lai Province, a rural, mountainous region that has a high population of ethnic minority students. AIP Foundation began working in this area in order to serve this particularly vulnerable community. Millions of ethnic minority people from more than 50 unique groups live in Vietnam. Many live in more remote areas, have lower literacy rates, and have lower incomes than those from the country's majority ethnic group, the Kinh. Ro Cham Hoang Anh, a student at la Ninh Primary School, is a member of the Ja Rai ethnic group.

In the upcoming years, AIP Foundation will continue this collaboration with Johnson & Johnson. *Helmets for Kids* has an operating budget of \$100,000 per year and plans to distribute over 17,000 helmets to students at existing program schools as well as new ones in five provinces of Vietnam. Additionally, the program will reach over 33,000 parents through education and thousands of teachers as well.

Helmets for Kids always has room for further funding. With existing program budget from Johnson & Johnson and other funding sources reserved for other activities such as public awareness raising, education, media coverage, and trainings, AIP Foundation would be able to invest the GiveWell grant funding into direct helmet distributions that have been proven to reduce risks of injury and death for more and more students.

With an additional \$250,000 in funding, AIP Foundation will be able to provide life-saving helmets for approximately 14,500 students additional over the upcoming years—almost *double* the number of helmets set to be provided already throughout the next three years. Consequently, *Helmets for Kids* can expand to additional schools in the existing program provinces as well as potentially expanding to other provinces in remote, underserved areas with large populations of ethnic minorities or less fortunate students.

Based off of our predicted costs-savings analysis, the additional funding from GiveWell would ultimately save approximately \$500,000 in prevented injuries, deaths, and loss of productivity. Overall, *Helmets for Kids* would save over \$15 million USD, directly reach over 1 million people, and indirectly reach over 4.5 million people throughout Vietnam.
