- A. What does your status as a PSO allow you to do that you could not otherwise?
- B. Do you have any plans to create more schools in New York? If so, please be specific about where and when you plan to create new schools.
- C. Please provide a breakdown of your expenses across your different programs: school creation and support, Scaffolded Apprenticeship Model, Practitioner Networks, Fund for Teachers, College Bound, Libraries for the 21st Century, and KnowledgeBase.
- D. What would an increase in donations (from individuals – beyond any funds received from us) allow your organization to do that it could not otherwise?

**II. Lessons learned.** Three of your programs – the Scaffolded Apprenticeship Model, Practitioner Networks, and much of the New Century II Initiative – appear to be focused on helping educators to identify problems and develop, execute, and test solutions using a data-driven approach. In order to get a sense for the likely impact of these programs, we need a sense for what sorts of problems are being addressed and what changes in practices are taking place due to data-driven examinations of these problems.

Please provide as many examples as possible of *specific* solutions to specific problems that have been implemented with the help of your programs. In each case, we are looking for:

- A. A description of the problem addressed.
- B. An account of what action plan was developed to address the problem, and what pre-existing evidence and reasoning indicated that this action plan was the best course of action.
- C. Any available data on the impact of the action plan taken.

We are most interested in large-scale action plans that affected large numbers of people, but are interested in as many examples as possible of policies – at low or high levels – that were settled on, implemented, and evaluated after implementation, with your program's help.
